### What is it?

The Central Oregon Youth Investment Foundation (COYIF) is a small foundation group of volunteers that have a federal tax exempt 501 ©(3) non-profit status filed with the IRS. The foundation is comprised of independent board members that are not employees of the Oregon Youth Challenge. They are an independent group of professionals and account for all donations, provide oversight and approval for any and all expenditures that the Youth Challenge Program requests to make from funds donated by parents, grandparents, grants, agencies and friends of Youth Challenge.

### Purpose Of The Foundation

The primary purpose of the foundation is to support the Oregon Youth Challenge Program and make resources available to the students and program that will create opportunities for continued success during and after graduation. This is done through the acceptance, approval and monitoring of donations as well as fund raising activities on behalf of the Youth Challenge Program.
